26/17	Approval of the Minutes of the last ordinary meeting held 26 th January 2026. Acceptance of the minutes was proposed by SC and seconded by LD. Accepted as a true record and signed by KA.	
26/18	Matters Arising (i) The blockage under the bridge, next to the Pub, has been cleared but SC reported that some of the debris was now further down the river. (ii) It remains too wet for the football posts and the new gate to be installed on the football pitch.	LW to chase up
26/19	Report by the County Councillors SP reported that : (i) The road at Pitt bridge is in need of repair. Vegetation clearance work will start shortly and traffic lights will be needed at the site. (ii) The Cutcombe Hill road repairs are progressing well. (iii) The recent Housing Sub-Committee meeting raised the problems with Magna again. KA added that, after discussions with Rachel Gilmore, they were hoping to arrange a meeting with Magna senior management. It appears that the package of work previously announced would not take place in full. Concern was expressed that without the whole package the new heating would be inefficient and expensive to run. (iv) Great House Street works were discussed at the LCN Highways sub-committee. A final decision on the solution has yet to be made. (v) The Boundary Commission report is due to be published on 3 rd March 2026. (vi) The Cutcombe crash inquest has been postponed again. (vii) A review of signage for lorries is being undertaken. The Council requested that the signage at Couple Cross be included in the review, as inappropriate lorries continue to comedown Church Street and then get stuck. KA had contacted Forestry England after a logging lorry became stuck and was told that contractors are instructed not to drive through the village. SC reported that the road through the village has been noticeably busier since the road works at Dunster had started.
